ABOUT ATCAA HEAD START

ATCAA Head Start started in 1984. We have six centers that serve children in Amador and Tuolumne Counties. Each center serves 16 children ages 3 and 4 years old. We also have California State Preschool funding which allows us to serve children for 6 hours a day. A few children are served through our home visiting program.

Early Head Start was started in 2010 through an expansion grant. We have 4 Early Head Start centers (2 in each county) that serve 8 children each (total of 32 children aged 18 months to 3 years). Pregnant women and children are served through our home visiting program.

ABOUT THE POSITION

- Organizational Leadership The Director of Early Childhood Services (ECS) will ensure that data is
 collected, analyzed, and used to guide instruction and program improvement. They will oversee
 program expansion opportunities through grant writing, collaborating with local agencies and utilizing
 local resources. The Director will maintain and create new and existing community collaborations such
 as agreements with school districts, and other community partners. The Director leads staff and
 supervises members services, programs, and events.
- **Financial Stewardship** The Director ensures that ATCAA Head Start's fiscal resources support operations and sustainability. The Director develops, proposes, and manages the annual budget and is responsible for budget development, tracking, forecasting, and reporting with input and assistance from appropriate staff.
- Grant Management The Director will prepare funding applications as required and oversee the
 program's implementation, evaluation, and development and serve as the Head Start/Early Head Start
 director as defined by federal grant expectations.

- Possess at a minimum, a baccalaureate degree or higher with a major or emphasis in human service management, communications, social services, early childhood education, or other related field
- At least three years management experience in programs serving young children, general education or social services including the following
- At least three years supervising multiple staff
- Program planning and development
- Budget preparation and management
- Public relations and community networking
- Training in and/or experience working with Trauma informed Practices
- Strong oral and written communication skills
- Proficient use of computer programs including spreadsheets, word processing, internet, and email

- Experience/Training in Dual Language Learning
- Federal or State grants management experience
